**Important Information About Your Practice**

We have written to you before about your practice moving to new and improved premises. I am pleased to let you know that your practice will relocate to the new premises, situated in the Goodman's Fields development in Aldgate, during September 2021.

As we advised when we wrote to you, we needed to agree a new contract for both East One Health and Whitechapel Health during 2019 and it made sense to bring the two practices together under one contract. The relocation will see both practices vacate their current premises and move as a joint list to the one site.

The practice will be called **Goodman's Fields Health Centre**. The new address is 11 Stable Walk, London, E1 8ZF (see map at the end of this letter). This is a new building designed to be a primary care health and wellbeing centre with excellent digital facilities, access to a wider range of health services and a resource for the local community to run health related activities.

**What does this mean for me?**

- It means that your healthcare will be provided from much better quality premises
- It will allow the practice to expand the services delivered over time and have more clinicians to help you with your health
- It will mean the practice will be able to offer patients the choice of seeing a wider range of team members to support their health and social care needs.

**What do I need to do?**

**You do not need to take any action. Your registration will automatically transfer to Goodman's Fields Health Centre.** You will be able to contact the practice, book appointments and access services in the **same** way that you do now. There are no plans to reduce reception or clinical staff as a result of these changes.

Although we hope that you will want to continue your registration with Goodman's Fields Health Centre, should you wish to register with another practice you can do so at any time by contacting a practice of your choice or by visiting the nhs.uk website.

## **What will happen to the East One Health and Whitechapel Health premises when the practices relocate to Goodman's Field Health Centre?**

When the East One Health practice moves from Deancross Street and Cable Street, a local practice currently in poor premises, City Square Medical Group, will move in. As a result, any patients that wish to remain at the Deancross Street site can do so through a simple re-registration process with City Square Medical Group. The Whitechapel Health premises will not be retained as they are not fit for modern GP services.

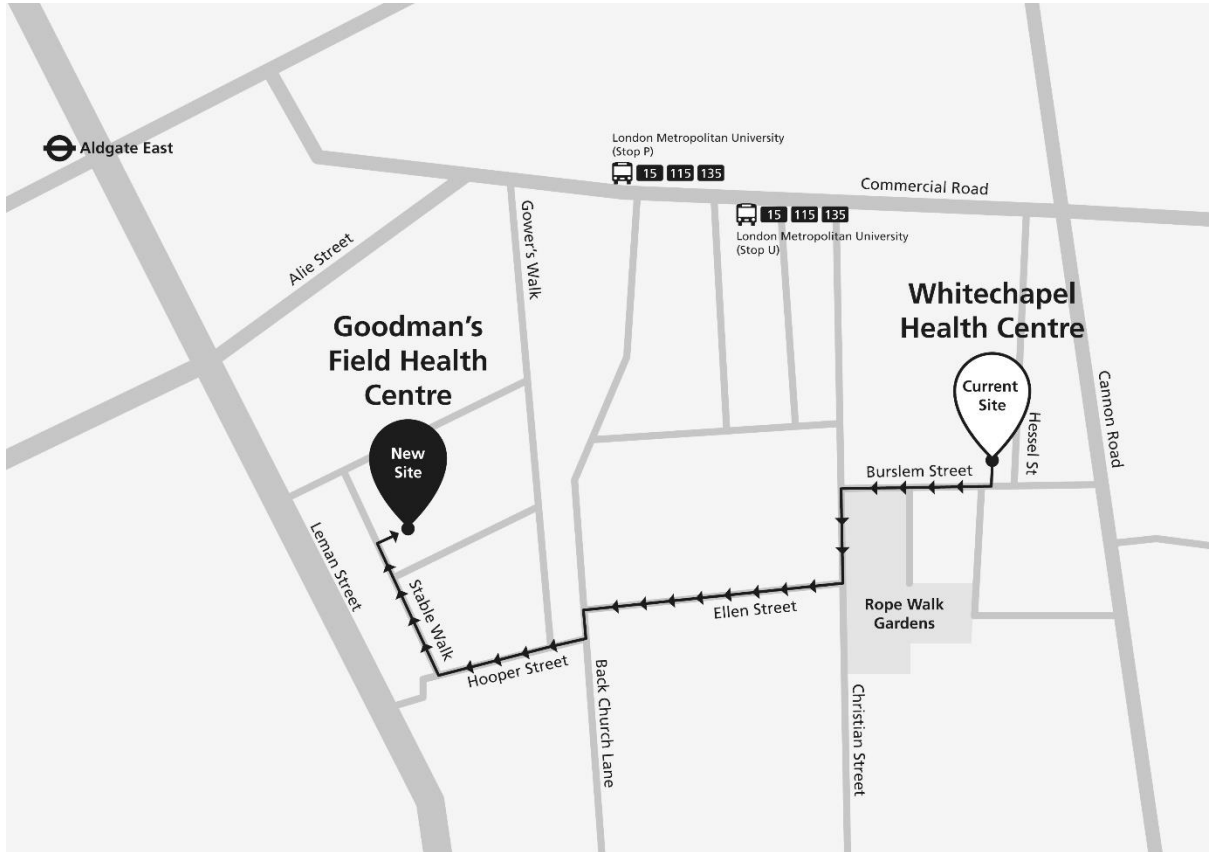
